

Crown Investments Corporation (CIC) Indigenous Bursary Application

Background

The Crown Investments Corporation will be providing five (5) \$5000 bursaries to Indigenous students attending a Great Plains College Campus for the next five years.**

Applications must be submitted by **September 30th** each year to be considered for the bursary.

Applications will be assessed by a committee of Great Plains College staff.

Bursary Program Eligibility & Selection Criteria

- 1.1 To be eligible for the Bursary, students in their first year of a Great Plains College program must:
 - (a) Complete and submit the appropriate application form.
 - (b) Be of self-declared Indigenous ancestry (Status First Nation, Non-Status First Nation, Metis or Inuit);
 - (c) Be admitted and registered full-time in a program of sixteen (16) weeks or more, to be completed on-campus, through distance delivery or a combination of on-campus and distance delivery;
 - (d) Have been a Saskatchewan resident during the past 12 months; and
 - (e) Have completed their last semester of high school with a minimum 65% average using the following classes:
 - (i) Grade 12 Core Classes
 - A. English Language Arts A30
 - B. English Language Arts B30
 - C. Social Studies 30, History 30, or Native Studies 30
 - D. Highest grade in a 20 or 30 level Math
 - E. Highest grade in a 20 or 30 level Science OR
 - (ii) Grade 11 Core Classes
 - A. English Language Arts 20
 - B. 20 level Math

- C. Chemistry or Biology (if applying for Environmental Science or Technology Programs)

OR

(iii) Grade 10 Core Classes

- A. English Language Arts B10
- B. Social Studies 10, History 10, or Native Studies 10
- C. Highest grade in a 10 level Math
- D. Highest grade in a 10 level Science.

1.2 To be eligible for the Bursary, students in their second year of a Great Plains College program must:

- (a) Complete and submit the appropriate application form – attached to this document.
- (b) Be of self-declared Indigenous ancestry (Status First Nation, Non-Status First Nation, Metis or Inuit);
- (c) Be admitted and registered full-time in a program of sixteen (16) weeks or more, to be completed on-campus, through distance delivery or a combination of on-campus and distance delivery;
- (d) Have been a Saskatchewan resident during the past 12 months; and
- (e) Have completed their first year of a two-year Great Plains College program with a minimum 65% average for all classes.

1.3 The Committee will make its selection of Bursary recipients based on:

- (a) Financial need (60% weighting); and
- (b) Community and/or campus involvement (40% weighting).

1.4 At the discretion of the Committee, preference may be given to students in designated Business, Industrial Training and Technology programs. Eligible programs are the following:

Welding, Electrician, Power Engineering, Administrative Assistant, Business Certificate, Business Diploma

**The value of each award shall be \$5,000.00, paid in two (2) installments: \$2,500 in the fall term and \$2,500 in the winter term. (i) Payment of the second installment of \$2,500 in the winter term is dependent on the recipient student continuing to be enrolled full-time and meeting the Great Plains College requirements for attendance and academic performance.
